Conditions of Booking (Clubs)

1. Bookings are strictly payment with order (where applicable), by cheque or credit/debit card.
2. Only Clubs holding valid BMF Affiliated membership are entitled to free space at BMF events. Free space offered to any other organisation will be at the discretion of the Organisers.
3. There must be no sub-letting of plots. Any Club wishing to "share" a plot with another Club must obtain permission from the Organisers in advance, and name all parties concerned. All such clubs MUST be BMF Affiliated.
4. Booking cancellations may be eligible for refund, less an administration fee, provided the organisers have received at least 30 days notice.
5. Any Club who has booked space but does not attend will be charged at Trade Rate, unless cancellation of plot has been received 30 days before the date of the show.
6. Entry is by Exhibitor Wristbands and Vehicle Passes, which will be sent prior to the event. No passes, no entry.
7. Stands should be ready for gates opening 9am – 5pm at ALL BMF shows
8. There is to be strictly no vehicle movement on site during show opening hours
9. Speed limit of 10 mph must be observed at all times on the Show site.
10. Exhibitors must not ride, or drive vehicles around the site during opening hours, or contravene the Road Traffic Act 1988/91 Motor Vehicles (off Road Events) Regs. 1992, at any time. E.g. no children riding on site. If you can't do it on the road - you can't do it on the Show site
11. All vehicles, trailers etc not contained within Exhibitor Club's space must be removed to the designated Exhibitor Parking Areas after unloading. Vehicles must not block avenues, or restrict emergency access. *Failure to comply will result in your vehicle being towed away or wheel clamped-at your own risk and expense*
12. BMF (Enterprises) Ltd cannot be held responsible for the safety of stands, goods, vehicles, equipment, cash etc whilst on the Show site.
13. BMF Affiliated clubs are covered under the BMF Insurance package, and are covered for third party and public liability claims. All such clubs will be expected to safeguard against such claims arising, by taking all reasonable steps with regard to Health and Safety policies etc. Risk assessments and fire safety certificates should be provided.
14. Exhibitor Clubs should protect their losses against Abandonment and Cancellation or curtailment of the event due to reasons beyond the Organisers control.
15. Exhibitor Clubs may stay overnight on their plot for security purposes but must not light bonfires, fireworks, play loud music, or behave in such a way as to cause a nuisance to others on site, and local residents.
16. Exhibitor Clubs using their own marquee, caravan, awning etc; must ensure it is mechanically sound, of good condition and appearance, is contained on their plot and is fully insured.
17. Exhibitor Clubs must not use loudspeaker equipment, or any amplified noise, i.e. P.A.system, music/video cassettes etc; unless in possession of an Exemption Form, supplied by the organisers.
18. Exhibitor Clubs must not, under any circumstances, sell food or drink.
19. Only silent generators are permitted on the Show site and may be used up to 11.00pm.
20. The Organisers reserve the right to ban goods from the site, which they consider not legal or suitable for the event. E.g. Weapons or controlled drugs.
21. No form of advertising material may be displayed or distributed at the event, other than on, or from, the Exhibitor Clubs stand.
22. Dogs must be kept on a lead, cleaned up after, and under strict control at all times.
23. The Organisers reserve the right to refuse bookings without reason being given.
24. All Exhibitors must ensure their stand space is cleared of all rubbish before they leave the show. Any exhibitor club leaving rubbish on their stand will be charged a clearance fee. Please use skips and bins provided.
